Fibers, Filaments & Yarns	Fibers & yarns applied to apparel, home textiles and industrial textiles, including high performance textiles and eco textiles.
Apparel Textiles	Fashion textiles, plus textiles with functions such as quick dry, anti-bacterial, anti-odor, UV-cut, far infrared, anti-static, insect repelling, anti-mildew, fragrant, heat retaining, stretch, easy cleaning, and more.
Home Textiles	Home and upholstery textiles with features such as: high abrasion, antibacterial, antifungal, flame-retardant, heat insulating, heat radiating, light shielding, and more.
Industrial Textiles	Textiles applied to shoemaking, bags and suitcases, architecture, personal protection, medical hygiene, transportation, packaging, environmental protection, sports, leisure and more.
Apparel, Accessories & Trimmings	OEM/ODM apparel & accessories. Trimmings such as buttons, embroidery, laces & fringes, patterns, ribbons, labels, interlinings, tailors' items, zippers and other trimmings for garment.
Personal Protective Equipment	Non-woven, melt-blown nonwoven, ear strap, medical masks, medical gloves, goggles, face shields, head covers, shoe covers, protective coveralls, isolation gowns and textiles with antibacterial and antiviral functions.
Smart Textiles/ Clothing	Textiles/Clothes which incorporate conductive materials or are embedded with electrodes to sense and capture variation data of wearer's vital signs as well as the environment. The data can then be sent to devices or the cloud for real time recording and computing, and suggestions are thus provided for adjustment or improvement.
Textile Machinery	Spinning, knitting, dyeing & finishing, printing, non-woven, melt-blown nonwoven and other textile machinery.
Sewing Equipment	Sewing machinery, sewing machine spare parts, other related equipment and face mask machine.
Textile-Related Products and Services	Textile inspection & certification, software applications for the textile industry, fashion information, e-management and related services.
