Textiles with post finishes such as lamination, coating, quilting, and more.
Home Textiles	<ol style="list-style-type: none"> 1. Bedding and upholstery textiles with features such as high abrasion, antibacterial, antifungal, flame-retardant, heat insulating, heat radiating, light shielding, and more. 2. Towel.
Industrial Textiles	<ol style="list-style-type: none"> 1. Textiles applied to shoemaking, bags and suitcases, architecture. 2. Industrial textiles with features such as high tenacity, personal protection, medical hygiene, transportation, packing, and more.
Apparel, Accessories & Trimmings	<ol style="list-style-type: none"> 1. OEM/ODM apparel. 2. Accessories such as socks & hosiery, hats, gloves, scarf, belt, bags and shoes. 3. Trimmings such as buttons, embroidery, laces & fringes, patterns, ribbons, labels, interlinings, zippers and more.
Auxiliaries & Dyestuff	Chemical agents and auxiliaries for dyeing and finishing of textiles.

Textile Machinery	Spinning, knitting, dyeing & finishing, printing, non-woven, melt-blown nonwoven and other textile machinery.
Sewing Equipment	Sewing machinery, sewing machine spare parts, face mask machine, and other related equipment.

TERMS & REGULATIONS

1. Participation

Registration

- (1) By submitting the application form to TTF, the applicant agrees to observe all the stipulated regulations and further regulations.
- (2) The application will come into effective as soon as it is confirmed and accepted by TTF.

Intellectual Property Rights / Copyright

- (1) The exhibitor warrants that the exhibits and packages thereof and the related publicity materials do not in any way whatsoever violate or infringe any third party's rights including trademarks, copyrights, designs, names and patents whether registered or otherwise.
- (2) Violation will result in immediate removal of the exhibits and two years suspension in TITAS. Exhibitors are responsible for all penalties without recourse or indemnity.

Insurance

Besides insuring exhibits in-transit from the port of shipment to the exhibition site, exhibitors are also urged to be adequately insured for fire, theft, accident and third party liability for the duration of the exhibition and during the time their displays are in storage in the organizer's warehouse.

On-Spot Sale

On-Spot sale of exhibits is strictly forbidden.

Operation of Exhibition

- (1) During show hours exhibitors shall keep their booths open and staffed at all times.
- (2) Exhibitors are requested to keep booth noise at a reasonable level and not to exceed 70 decibels.

2. Booth

Booth Allocation

- (1) TTF will assign a booth number and location in accordance with the nature of exhibits, or in the manner the organizer deems appropriate.
- (2) TTF reserves the right, should an assigned booth remain unoccupied on the opening day without reasonable cause, to assign said booth to other exhibitors, or to use said booth in any manner deemed suitable.

Subletting of Booth(s)

Exhibitors are not allowed to assign, sublet or apportion the whole or any part of their booths, or have representatives, equipment or materials from firms other than their own in their booth without the written consent of TTF.

3. Cancellation

- (1) If exhibitor refuses defaults in making payment by the due date, TTF has the right to terminate the registration.
- (2) In case of exhibitor's withdrawal from participation, the prepaid payment shall not be refunded.

4. Change or Termination of Exhibition

- (1) TTF reserves the right to change the venue and duration of the exhibition. In the event of a change of venue, date of the exhibition, exhibitors shall not be entitled to any claim for compensation.
- (2) In no event shall TTF be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, fire, flood, storm, epidemic, earthquake, explosion, blockade, embargo, inclement weather, restraints or orders of government or public agency and other accident. TTF will not be liable to the Exhibitor other than refund the remaining amount of the exhibit space fee deduct necessary expenses incurred from the Exhibition.

5. Supplementary Clauses

- (1) Whenever necessary, TTF may add supplementary clauses in addition to the above regulations.
- (2) Additional written regulations shall constitute a part of the above-stated terms or the Exhibitor's Manual and shall be observed by exhibitors.
